

## SHOWMAX TERMS AND CONDITIONS FOR USING THE DSTV PAYMENT FACILITY ("TERMS AND CONDITIONS")

1. The **DStv Payment** facility allows a qualifying ShowMax subscriber, who is also a DStv subscriber, to add ShowMax to their DStv account. In doing so, the subscriber permits MultiChoice to collect the funds for both DStv and ShowMax on one debit order on the existing date that MultiChoice collects the debit order for subscription to the DStv service ("**Monthly Debit Order Collection Day**").
2. DStv Premium customers with an Explora (and who are paying the monthly Access Fee) will automatically qualify for ShowMax at R69 (sixty nine) per month ("the Special price") when paying ShowMax via their DStv account (via debit order). This price is valid to 31 March 2018.

### Requirements for using the DStv Payment Facility

3. You may only use DStv Payment facility if you –

3.1 are a natural person who has subscribed to, and has an active subscription to a DStv or GOtv package for your private use in South Africa;

3.2 are currently paying for your DStv subscription via monthly debit order, including recurring credit card debit; and

3.3 have registered as a user of the DStv website (<http://www.dstv.com>) by creating a username and password, in accordance with the terms of use of the DStv website.

4. If you no longer meet any of the requirements listed in paragraph 1, you will not be able to use this facility and must choose another payment method before your next Monthly Billing Date.

5. If you no longer meet any of the requirements listed in paragraph 2, you will not be eligible for the Special price for ShowMax.

### New ShowMax Customers Making use of the DStv Payment facility

6. To make use of the DStv Payment facility, you must –

6.1 choose "DStv Payment Facility" as your Payment Method when you register or

at any other time by logging into the ShowMax website (<http://www.ShowMax.com>) and updating your ShowMax Account;

### **Existing ShowMax Customers Making use of the DStv Payment facility**

7. To change your existing payment vendor to DStv Payment facility, you must –  
7.1 go to "my account" on the ShowMax website (<http://www.ShowMax.com>) and choose "DStv Payment Facility" as your new Payment Method;

### **New and existing customers must:**

7.2 provide MultiChoice with information which we require to add ShowMax to your DStv account; including your username, email address or mobile number and password;

7.3 accept these Terms and Conditions.

8. Once you have chosen this facility, by complying with 2, your ShowMax Monthly Fee will be automatically included in your next DStv debit order on your next Monthly Debit Order Collection Day.

9. The terms and conditions that apply to paying your DStv account by debit order will apply to payment of your ShowMax Monthly Fee.

10. You may change your payment method at any time on the ShowMax website. If you change your payment method during a Subscription Period, but before the next Monthly Debit Order Collection Day, the change in payment method will be effective from your next Monthly Billing Date and your next debit order will include your ShowMax Monthly Fee. **If you are paying the Special price for ShowMax and you change your payment method, the Special price for ShowMax will stop and you will from then on pay the prevailing monthly premium.**

11. You will only be able to add a maximum of five ShowMax products to your DStv account.

**12. The Special price for ShowMax only applies to a DStv Explora for which you have a full DStv Premium subscription (including the monthly Access Fee) and which is paid via your DStv account and paid by debit order.**

**13. You can have a maximum of 5 ShowMax subscriptions at the special price per account if you meet the requirements set in clauses**

2 and 12 above.
